## **SCHOLARSHIPS\***

Scholarships (tax free) need to be applied for separately and are for applicants with a 1st, 2:1, master's or PhD, though in exceptional circumstances, they may be awarded to a graduate with a 2:2 and significant relevant experience. Scholars are entitled to benefits of membership to the professional body, professional body subject specialist events and webinars, online and face-to-face workshops across the country, subject specialist mentors and coaching, community of scholars, access to classroom resources, continuing professional development (CPD) and networking events during ITT year and Alumni.

## SALARIED COURSES & THE APPRENTICESHIP ROUTE

Salaried courses and the apprenticeship route are available in some subjects for trainees with a relevant level of teaching experience and a supporting school. There are generous bursaries for some subjects and financial support for the school. Please enquire for further details.

#### TUITION FEE AND MAINTENANCE LOANS

A tuition fee loan is available to cover course costs up to £9,250 and is paid directly to your training provider. You can apply for a tuition fee loan regardless of your household income. If you have an existing student loan you can take out an additional loan to cover your teacher training and you will only start making repayments when you earn over the threshold (currently £27,575 a year).

A maintenance loan of up to £12,295 may be available to you to help with your living costs, see <a href="https://www.gov.uk/studentfinance/new-fulltime-">www.gov.uk/studentfinance/new-fulltime-</a> **students** for further details. This loan would be paid directly into your bank account at the start of each term.

#### ADDITIONAL FINANCIAL SUPPORT

There is extra financial support available, which does not have to be paid back if you are a parent, have an adult dependent or a disability. For example, if you have children you could be entitled to 85% of your childcare costs of up to £179.62 a week (1 child) or up to £307.95 a week (2 or more children) from the Childcare grant and up to £1,821 from the Parents' learning allowance.
